


DANE is the responsible of computing a TFP value in order to get one of many criteriums to carry out the minimum wage agreement. Role determined by National Development Plan 2018-2022.

DANE begins to designing and constructing the TFP index following the LAKLEMS methodological document, counting on the technical support of this team.

The entity measures TFP at constant prices based on 2015 from the value-added approach for the 2020 wage agreement (information available until September 2020).

- → DANE measures TFP at constant prices based on 2015 from the value-added approach with updated information for 2018, 2019p and 2020pr.
- \ominus

DANE measures TFP at **constant prices based on 2015** from the gross-output approach, adding a measure of the contribution from Laboral input with a gender perspective.










